KNOWSLEY METROPOLITAN BOROUGH COUNCIL

(PROHIBITION AND RESTRICTION OF WAITING AND LOADING AND PARKING PLACES) (CIVIL ENFORCEMENT AND CONSOLIDATION) ORDER 2015 (AMENDMENT NO 26) (HUYTON LANE, SERVICE ROAD, HUYTON) EXPERIMENTAL ORDER 2017

Knowsley Metropolitan Borough Council in exercise of its powers under Sections 1, 2, 4, 9, 10, 19, 32, 35, 45, 46, 47 53 and 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the 1984 Act") as amended and the Traffic Management Act 2004 ("the 2004 Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act where appropriate, hereby makes the following Order.

1. This Order shall come into operation on 17th August 2017 and may be cited as the Knowsley Metropolitan Borough Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2015 (Amendment No.26) (Huyton Lane, Service Road, Huyton) Experimental Order 2017
2. The Knowsley Metropolitan Borough Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2015 shall be amended by the temporary suspension of the Map Schedules specified in First Schedule to this Order for the duration of this Order.
3. The Knowsley Metropolitan Borough Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2015 shall be amended by the temporary insertion and addition of the Map Schedules specified in the Second Schedule to this Order for the duration of this Order.

4. The Knowsley Metropolitan Borough Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2015 shall be amended by the temporary insertion and addition of the Third Schedule in to Schedule 1 of 2015 Order for the duration of this Order.
5. The Knowsley Metropolitan Borough Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2015 shall continue in full force and effect.
6. The effect of this Order is to replace those provisions of the Knowsley Metropolitan Borough Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2015 in so far as they relate to the following restrictions on Huyton Lane, Service Road, Huyton

Permit holders only parking (at all times)

Huyton Lane Service Road – its north west side commencing at a point 32 metres northwest of its southernmost junction with Huyton Lane and extending in a north easterly direction for a distance of 60 metres.

7. Pursuant to section 10(2) of the 1984 Act and subject to the provisions of section 10(3) of the 1984 Act the Council's Executive Director (Place) or a person authorised by that Director may if it appears to that person essential in the interests of the expeditious, convenient and safe movement of traffic, or of the provision of suitable and adequate parking facilities on the highway, or for the preserving or improving the amenities of the area through which any road affected by this order runs, and after consulting with the Chief Officer of Police, modify or suspend the operation or any provision of this Order.
8. This Order shall continue in force for a period of not exceeding 18 months from the date specified in Article 1 of this Order or until it is made permanent.

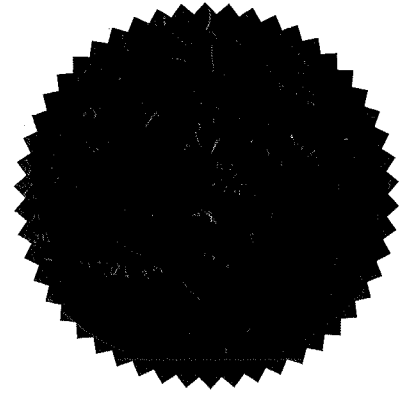
