1. Introduction

- 1.1 This report sets out the representations received in response to an additional public consultation held to deal with a further Proposed Modification to the Knowsley Local Plan Core Strategy.
- 1.2 The further modification was proposed following the publication of a Written Ministerial Statement on Wind Energy in June 2015 and changes to national Planning Practice Guidance.
- 1.3 The Proposed Modification was published for consultation on 4 September 2015, and the consultation period ran until 2 October 2015.
- 1.4 All parties in the Core Strategy consultation database were notified directly (by letter or e-mail) of the arrangements for the consultation and the consultation was also advertised in the Liverpool Echo between 4 and 11 September 2015. Consultation documents were made available via the Council's website, and in libraries and One Stop Shops across the borough.
- 1.5 13 representations were received during the consultation period, and they are reproduced here. Personal details (including signatures, personal telephone numbers and private postal or email addresses) have been removed, although the names of respondents (and the organisations they represent, if applicable) are published.
- 1.6 Responses are ordered by a Representor ID number this is consistent with previous consultations during preparation of the Knowsley Local Plan Core Strategy.

Further Modifications to the Knowsley Local Plan: Core Strategy

Knowsley Council submitted the **Knowsley Local Plan: Core Strategy** ('the Plan') to the Government in 2013. Planning Inspector Mr Martin Pike is undertaking an Examination in Public into the soundness and legal compliance of the Plan. Public hearing sessions were held in November 2013 and July 2014. In autumn 2014, the Council consulted on a range of proposed modifications to the Plan which had arisen as a result of the Examination process. Further public hearing sessions into these modifications were held in June 2015.

Following this, also in June 2015, the Secretary of State for Communities and Local Government issued Written Ministerial Statement on Local Planning, which introduced changes to national policy on wind energy. The Inspector has now advised the Council that the Plan will need to be modified to ensure that it reflects these changes.

Please be aware that this public consultation is limited to <u>only</u> this further modification which relates to wind energy. Consultation responses which relate to other parts of the Plan will not be accepted. Guidance notes and response forms are available to help you submit representations on the relevant

matter and in the correct format. All responses received will be publicly reported and submitted to the Inspector.

ON BEHALF OF UNITED UTILITIES- REPRESENTATION FOR POLICY CS23 OF THE FURTHER PROPOSED MODIFICATION (SEPTEMBER 2015) KNOWSLEY LOCAL PLAN CORE STRATEGY

On behalf of United Utilities this letter constitutes a formal written representation in respect of the current consultation on the Proposed Modification to *Policy CS23* of the adopted Local Plan Core Strategy

The proposed further modification outlined by Knowsley Borough Council (the Council) is set out below:

9.17 Policy CS 23 will apply to all types of renewable and low carbon technology, with the exception of wind turbines. Policies relating to the development of wind turbines will be included within the Local Plan: Site Allocations and Development Policies document. Before adoption of that document, wind turbine proposals will be considered against relevant national policy including the Government's Written Ministerial Statement on this issue, made on 18 June 2015. The Written Ministerial Statement advises that local planning authorities should only grant planning permission for proposals including one or more wind turbines if: the proposed development site is in an area identified as suitable for wind energy development in a Local or Neighbourhood Plan; and, following consultation, it can be demonstrated that the planning impacts identified by affected local communities have been fully addressed and therefore the proposal has their backing.

The reason stated for the modification is to ensure that the Core Strategy accounts for the provisions of the Written Ministerial Statement on Wind Energy dated 18th June 2015. The contents of this statement are also reflected in the amendments made to the Renewable and Low Carbon Energy Planning Practice Guidance (PPG).

Response

We respectfully ask that the Council recognise that the purpose of the Written Ministerial Statement and amendments to the PPG are not to introduce new policy, but rather to explain how extant policy within the National Planning Policy Framework should be used in practice. This being the case, the Written Ministerial Statement and PPG should be subservient to the wording of the National Planning Policy Framework (NPPF), in particular paragraph 98 which states in part, that local planning authorities should approve renewable energy proposals 'if its impacts are (or can be made) acceptable'. Paragraph 98 goes on to state that 'local planning authorities should also expect subsequent applications for commercial scale projects





outside these areas to demonstrate that the proposed location meets the criteria used in identifying suitable areas'. Acknowledgement should also be made of the large body of national energy policy and the legal obligations to reduce greenhouse gas emissions imposed by the Climate Change Act. The Written Ministerial Statement and amendments to the PPG do nothing to amend this established law and policy or to lessen the weight that they carry.

In acknowledgment of these legal and material planning considerations we would suggest the following rewording of the proposed Policy CS 23 modification, recognising that the purpose of the development plan is not to replicate the wording of national planning policy:

9.17 Policy CS 23 will apply to all types of renewable and low carbon technology, with the exception of wind turbines. Policies relating to the development of wind turbines will be included within the Local Plan: Site Allocations and Development Policies document. Before adoption of that document, wind turbine proposals will be considered in accordance with legal and material planning consideration s including relevant national planning policy as set out in the National Planning Policy Framework and Planning Practice Guidance.

Furthermore on behalf of United Utilities we respectfully ask that the Council in the production of the Local Plan: Site Allocations and Development Policies document, recognise the benefits of wind energy. These benefits include the reduction of carbon emissions, helping to reduce the effect of global warming and the provision of clean green renewable energy. These important benefits are inherently sustainable and therefore accord fully with the objectives of national planning policy.

The Council should also recognise the benefits that wind turbines can play in the provision of direct on-site energy generation for large energy users such as utility companies and other providers of essential infrastructure.
