above-named order ("the Order") under Section 84 of the Road Traffic Regulation Act 1984. The effect of the Order will be to: Revoke the existing traffic regulation known as Knowslev Metropolitan Borough Council (Various Roads. Kirkby and Knowsley) (50mph Speed Limit Order) 2006 in so far as it relates to the roads described in the

Schedule to this Order. introduce a speed limit order limiting vehicle speeds to the following speeds on the following on the following

lengths of highway in Kirkby Knowsley -1 a speed limit of 50mph on the following lengths of road -

- East Lancashire Road both carriageways from its junction with Hewitts Lane to its junction. with Alchemy Way
- Coopers Lane from a point 150m north of its junction with East Lancashire Road to its junction
- with Fast Lancashire Road Knowsley Wood Lane westbound carriageway from its roundabout junction with the M57 Junction 4 to its junction with the A580 East Lancashire Road

1,770 metres in a westerly direction to the Knowsley Metropolitan Borough/Liverpool City Boundary

- Knowsley Wood Lane eastbound carriageway from the Knowsley Metropolitan Borough/Liverpool City Boundary to its roundabout junction with the M57.
- 2 speed limit of 40mph on the following lengths of road -
- East Lancashire Road both carriageways from its junction with Alchemy Way for a distance of

Moorgate Road South both carriageways for its entire length

- Moorgate Road North both carriageways from its junction with the East Lancashire Road for a distance of 65 metres in a northerly direction
- M57 Junction 4 roundabout entire circulatory carriageway Ormskirk Road from its junction with the East Lancashire Road to a point 65m north
- its junction with Mill Lane Knowsley Lane from its the junction with the East Lancashire Road to a point 155m south
- of its roundabout junction with Kitling Road.
- 3 speed limit of 20mph on the following lengths of road -
- · Ribblers Lane from its interface with Schol Lane for a distance of 180m in a northwesterly direction
- School Lane from its interface with Ribblers Lane to its junction with the B5194 School Lane.
