(PROHIBITION AND RESTRICTION OF WAITING AND LOADING AND PARKING PLACES) (CIVIL ENFORCEMENT AND CONSOLIDATION) ORDER 2015 (AMENDMENT NO 111) (HIGHER ROAD AND MANSELL ROAD HALEWOOD) ORDER 2025

NOTICE IS HEREBY GIVEN that on 30th September 2025 the Knowsley Metropolitan Borough Council ("the Council") made the above-named order ("the Order") under Sections 1, 2, 4, 19, 32, 35, 45, 46, 47, 53 and 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the 1984") Act"). The effect of the Order is to amend the Knowsley Metropolitan Borough Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2015 as amended ("the 2015 Order") by prohibiting waiting at any time on the following lengths of road -

- Higher Road, Halewood southern side of the carriageway from a point 135 metres southeast of its of junction with Torrington Drive to a point 10 metres west of its junction with Leather's Lane.
- Mansell Road, Halewood both sides of the carriageway from its junction with Higher Road for a distance of 15 metres in a southerly direction.

The 2015 Order is amended by the revocation of the Map Tiles specified in Schedule 1 below and by the insertion of the Map Tiles specified in the Schedule 2 below. The Order comes into operation on 3rd October 2025.

If any person wishes to question the validity of the Order or any of the provisions contained within it, on the grounds that it or they are not within the powers conferred by the 1984 Act, or that any requirement of the 1984 Act or of any instrument made under it has not been complied with in making the Order, that person may within six weeks from the date that the Order was made apply for that purpose to the High Court.
