

ROAD TRAFFIC REGULATION ACT 1984

KNOWSLEY METROPOLITAN BOROUGH COUNCIL (PROHIBITION AND RESTRICTION OF WAITING AND LOADING AND PARKING PLACES) (CIVIL ENFORCEMENT AND CONSOLIDATION) ORDER 2015 (AMENDMENT NO 119) (LEATHERS LANE AND BEECHWOOD AVENUE HALEWOOD) ORDER 2025

NOTICE IS HEREBY GIVEN that the Knowsley Metropolitan Borough Council ("the Council") proposes to make the above-named order ("the Order") under Sections 1, 2, 4, 19, 32, 35, 45, 46, 47 53 and 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the 1984 Act"). If the Order comes into force the effect will be to amend the Knowsley Metropolitan Borough Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2015 as amended ("the 2015 Order") by prohibiting waiting at any time on the following lengths of road:-

- i) Leather's Lane, Halewood (west side) from a point 52 metres north of its junction with Beechwood Avenue for a distance of 74 metres in a southerly direction.
- ii) Leather's Lane, Halewood (east side) from a point 16 metres north of its junction with Roseheath drive for a distance of 52 metres in a southerly direction.
- iii) Beechwood Avenue, Halewood (both sides) from its junction with Leather's Lane for a distance of 12m in a north-westerly direction

The 2015 Order would be amended by the revocation of the Map Tiles specified in Schedule 1 below and by the insertion of the Map Tiles specified in Schedule 2 below. The proposed Order would come into operation on the date that the Council publishes a notice stating that the Order has been made.
