Regulation 9A of the Neighbourhood Planning (General) and Development Management Procedure (Amendment) Regulations (2016)

The Council will then consider representations and make a decision whether or not to designate a Neighbourhood Forum, no later than no later than 13 weeks from the date immediately following that on which the application is first publicised.

Once a Neighbourhood Forum is designated then it can engage and consult with the wider community to develop a plan for their neighbourhood.

IMPORTANT

- 1. The Council will only accept Neighbourhood Forum applications in areas where:
 - A Neighbourhood Area has been designated; or
 - An application to designate a Neighbourhood Area has been submitted in tandem.
- 2. In order for Knowsley Council to designate a Neighbourhood Forum to act on behalf of a Neighbourhood Area, the Council needs to be satisfied that the following conditions contained in Section 61F(5) of Schedule 9 of the Town and Country Planning Act 1990 (as mended by the Localism Act 2011) are met:
 - The proposed forum is established for the express purposes of promoting or improving social, economic and environmental well being of an area that consists of or includes the Neighbourhood Area concerned (whether or not it is also established for the express purpose of promoting and carrying on of trades, professions or other business in such an area).
 - Membership is open to and includes a minimum of 21 individuals each of whom:
 - a. Live in the neighbourhood area concerned;
 - b. Work there (whether for business carried out there or otherwise); and
 - It has a written constitution (as detailed in section 4).
